Scheme

C H A R I T Y C O M M I S S I O N

In the matter of the Charity known as The Alfred Palmer Memorial Field, in the Parishes of Stratfield Mortimer and Wokefield, in the Royal County of Berkshire, regulated by conveyance and trust deed dated the 15th June 1939; and
In the matter of the Charities Act 1960.

THE CHARITY COMMISSIONERS FOR ENGLAND AND WALES HEREBY ORDER that the following Scheme be approved and established:-

S C H E M E

1. Administration of Charity. The above-mentioned Charity and the property thereof specified in the schedule hereto and all other the property (if any) of the Charity shall be administered and managed subject to and in conformity with the provisions of the above-mentioned conveyance and trust deed dated the 15th June 1939 as varied or affected by the provisions of this Scheme.

2. Letting. The Trustees of the Charity may grant a lease to the Mortimer Football Club of the property specified in the schedule hereto and belonging to the Charity as a site for a sports pavilion for a term of 25 years at the initial yearly rent of £50 subject to increase as in the lease provided which lease shall contain all usual provisions including provisions for the upkeep, repair, insurance and maintenance of the property of the lessees.

3. Application of income. The Trustees shall apply the clear income of the Charity for the upkeep, maintenance and improvement of the recreation field belonging to the Charity.

4. Questions under Scheme. Any question as to the construction of this Scheme or as to the regularity or the validity of any acts done or about to be done under this Scheme shall be determined by the Commissioners upon such application made to them for the purpose as they think sufficient.

SCHEDULE

Land containing 163 square yards or thereabouts being part of the land containing 5.105 acres or thereabouts situate at Stratfield Mortimer and Mortimer West End, in the Royal County of Berkshire numbered 49 and 492 on the Ordnance Survey map (1900 edition) and comprised in the above-mentioned conveyance and trust deed dated the 15th June 1939 and made between Henry Arthur Benyon of the first part, Gerald Eustace Howell Palmer and four others of the second part and Neil William Gardiner and two others of the third part and recorded in the books of the Charity Commissioners pursuant to section 29(4) of the Settled Land Act 1925 on the 20th September 1939.

Note. The above-mentioned land is vested in the Official Custodian for Charities by virtue of an Order of the Commissioners of the 5th March 1940 as affected by the provisions of the Charities Act 1960.
